Important Dates and Instructions

1. **Consent Letter Distribution – Saturday, 16th November 2024**

On this date, a consent form will be sent home with your child. Kindly fill out this form and return it along with a copy of either parent's Aadhar card, linked to an active mobile number, as this is necessary for receiving confirmation SMS once the APAAR ID is created.

2. **Open Day – Saturday, 23rd November 2024**

On Open Day, the class teacher will ask you to sign in their register as proof that you have completed the APAAR registration process.

Completing this process is essential, as it will become mandatory for all students in the future. By doing it together, we can make sure every student is set up for success with this valuable academic resource.

APAAR (Automated Permanent Academic Account Registry)

APAAR ID Features:

- A **12-digit unique ID** for every student, storing all academic records digitally in one place.
- Functions as a **permanent digital identity** within the education system, ensuring that each student's credentials are securely managed and accessible.

Key Benefits of APAAR ID:

1. **Empowers Students:** Allows students to access their own comprehensive academic records.
2. **Dropout Monitoring:** Assists in identifying and supporting students at risk of dropping out.
